From I-94: Take 10 (Lodge) South to Larned Street exit. Exit is on left. Continue on Larned for two blocks. Right on Griswold and right into parking structure in 150 West Jefferson.

From M-14: Take I-96 to 10 South/Civic Center (Lodge) downtown to Larned Street/Cobo Civic Center exit. Exit is on left. Continue on Larned for two blocks. Right on Griswold and right into parking structure in 150 West Jefferson.

From I-75: Take I-75 and follow I-375 to Jefferson Avenue west. Turn right on Griswold. Make immediate left into parking structure in 150 West Jefferson.

From Canada: Windsor Tunnel. Turn left onto Jefferson Avenue. Turn right on Griswold. Make immediate left into parking structure in 150 West Jefferson.
