### Driving Directions

**From North:** Take US-131 South to Business Route 131 Exit. Follow Business Route 131 South (turns into North Westnedge Avenue), through light at Kalamazoo Avenue. Turn left at West Michigan Avenue to light at Rose St. Turn right onto Rose St. Miller Canfield Building is the third building on the left, parking ramp entrance for visitors is on Rose St. Enter Lobby and take elevator to 5th floor.

**From South:** Take 131 North to Stadium (Business 94). Follow Stadium east to West Michigan. Take West Michigan to the light at Rose St. Turn right onto Rose St. Miller Canfield Building is the third building on the left, parking ramp entrance for visitors is on Rose St. Enter Lobby and take elevator to 5th floor.

**From East:** Take I-94 West to the Downtown Kalamazoo exit. Follow Business Route 94 to East Kalamazoo Avenue. Continue on East Kalamazoo Avenue to Rose Street. Turn left on Rose Street. Take Rose St. through the light at West Michigan Ave. Miller Canfield Building is the third building on the left, parking ramp entrance for visitors is on Rose St. Enter Lobby and take elevator to 5th floor.

**From West:** Take I-94 East to US-131 N. Exit US-131 at exit 36A toward Kalamazoo. Turn right and continue into downtown Kalamazoo where Stadium Dr. turns into West Michigan Ave. take to light at Rose Street. Turn right onto Rose St. Miller Canfield Building is the third building on the left, parking ramp entrance for visitors is on Rose St. Enter Lobby and take elevator to 5th floor.
