Driving Directions

From Detroit: Take 96 to Downtown Lansing exit, 496, and follow 496 to Grand Avenue/Downtown (Exit 7A). Follow Grand five blocks to the Radisson Hotel. Parking ramp is just beyond the Radisson, entrance on your left. Offices are in the building directly behind the Radisson. Entrance is on Washington Square (120 North Washington Square, Suite 900).

From Grand Rapids: Take 96 East to 496, and follow 496 to Walnut/Pine Streets (Exit 6) and merge on to West Main Street. Take Main Street to Grand Avenue and turn left. Follow Grand five blocks to the Radisson Hotel. Parking ramp is just beyond the Radisson, entrance on your left. Offices are in the building directly behind the Radisson. Entrance is on Washington Square (120 North Washington Square, Suite 900).

From Kalamazoo: Take 69 to 496, and follow 496 to Walnut/Pine Streets (Exit 6) and merge on to West Main Street. Take Main Street to Grand Avenue and turn left.
