Driving directions

From Metro Airport: Take I-94 East (Detroit) to I-75 North. Continue on I-75 North and exit at Crooks Road. Take Crooks Road South (left) to the Troy Corporate Center located on the east side (left) of the intersection just north of Long Lake Road.

From Auburn Hills Area: Take I-75 South and exit at Crooks Road. . . Take Crooks Road South (left) to the Troy Corporate Center located on the east side (left) of the intersection just north of Long Lake Road.

From Downtown Detroit: Take I-75 North and exit at Crooks Road. . . Take Crooks Road South (left) to the Troy Corporate Center located on the east side (left) of the intersection just north of Long Lake Road.

From Farmington Area: Take I-275 North to I-696 East. Continue on I-696 to I-75 North. Take Crooks Road South (left) to the Troy Corporate Center located on the east side (left) of the intersection just north of Long Lake Road.
